Emergency overview: WARNING! CAUSES RESPIRATORY TRACT, EYE AND SKIN

#### **Potential acute health effects**

**Chronic effects**: Once sensitized, a severe allergic reaction may occur when subsequently exposed to very low levels.

**Carcinogenicity**: Contains IARC 2B classified carbon black. IARC classifies carbon black as a 2B carcinogen based rat inhalation tests performed on high dust exposures. IARC concluded that "there is inadequate evidence in humans for the carcinogenicity of carbon black". There is no human dust exposure to carbon black when using a finished ink product containing carbon black.

**Mutagenicity**: No known significant effects or critical hazards. **Teratogenicity**: No known significant effects or critical hazards. **Fertility effects**: No known significant effects or critical hazards.

## Section 4. First aid measures

**Eye contact:** Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. #### Section 6. Accidental release measures

Large spill: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). # Section 7. Handling and storage

**Handling:** Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed.
